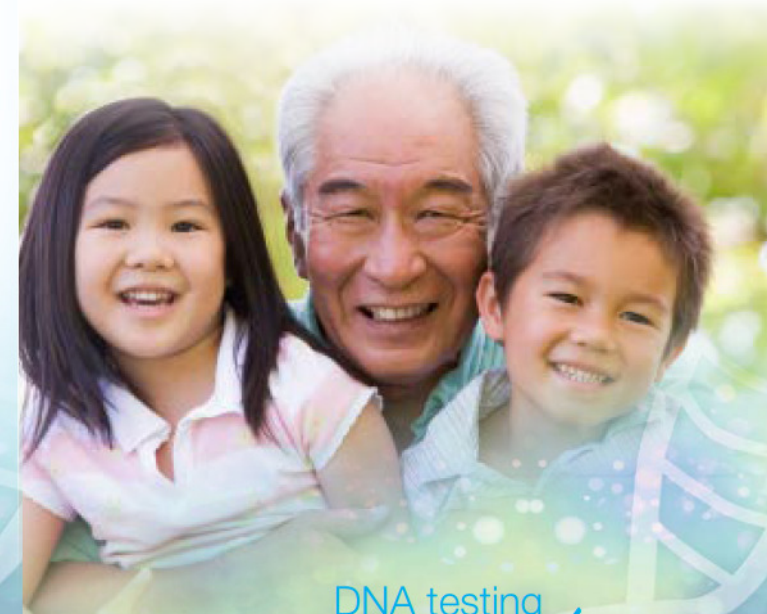

What is Immigration DNA testing?

The Department of Immigration and Border Protection (DIBP) will at times ask an applicant or sponsor for confirmation of a biological relationship for entry applications to Australia.

This confirmation may be in the form of a DNA test to confirm maternity, paternity or other another biological relationship.

What is the cost of an immigration DNA test?

We offer a wide range of testing methods available for determining biological relationships for immigration applications, including both paternity testing and maternity testing.

We are also able to offer other relationship tests between Siblings, Aunts/Uncles, Nieces/Nephews and Grandparents etc. through our relationship testing services.

Our NATA accredited legal Immigration Paternity testing is available from only **\$595.00** if all parties are in Australia and from **\$1095.00** when parties are overseas.

This pricing includes DNA analysis of the mother, father and child (This excludes any fees charged by the sampler). Additional people can also be included with an added cost for each extra participant.

What is the process I need to follow?

At easyDNA our Immigration Department treats every case on an individual basis. Our qualified team will advise you on the best testing methods for your case.



Do any test participants live outside Australia?

easyDNA operates through a network of over 23 offices world-wide. We can organize testing when test participants live in various parts of the world. Test participants can have DNA test kits sent to various locations.

For people being tested outside of Australia collection is arranged through the nearest Australian embassy and the DNA kit will be sent direct from us to the embassy involved to arrange sample collection (A fee may be payable in the local currency to the embassy for sample collection and this is not included in the cost of your test.)

Once all samples have been collected and identification has been authenticated, the samples will be labelled and sealed in the envelopes provided and sent to us for testing.

If all the applicants reside in Australia?

Once your order has been placed and payment has been received, the DNA Sample Collection Kit will be specifically prepared for your case and dispatched to your nominated GP/ Medical Professional (Sample Collector).

Our DNA sample collection kits contain everything you will need for the sample collection, including submission forms, sampling instructions and the oral swabs.

Once the kit arrives, you will need to make an appointment with your chosen Sample Collector who will be responsible for collecting all DNA samples.

All participants, inside or outside Australia will need to provide two passport-sized photos and an ID document to confirm identity. These will be signed and dated by the sampler. Also, an affidavit will need to be signed on the same day as the samples collection. **Again, easyDNA will assist with this and guide you.**
